Product Integration Started on January 1, 2023


Commercial

Existing Authorizations

We are committed to facilitating a seamless transition for Tufts Health Plan Commercial members who transition to Harvard Pilgrim Health Care.

- Existing authorizations will be valid through the applicable expiration date.
- Providers do not need to submit duplicate authorization requests for the same service/time period for transitioning members.

Important Reminders About Pharmacy Authorizations

- The integration of our commercial products will continue through 2024. Transitions
 will be staggered and aligned with the members' plan renewal dates.
- To ensure our members have uninterrupted access to their medications and reduce your administrative burden, we will transfer all active prior authorizations.
- All active prior authorizations will remain valid for the length of the approval.
- There is no need to submit a second prior authorization request if an active authorization has already been obtained.



- For patients receiving inpatient care at the time of their plan transition, medical care management services will continue to be provided by Tufts Health Plan's care management team.
- Upon discharge, the case will be transferred to Harvard Pilgrim Health Care's care management team.



Medical Claims Submission

Continue to follow the claim submission guidelines and policies for the health plan that is in effect for the member at the time of service.

Member's plan on date of service	Medical claim submission
Tufts Health Plan member on the date of service	Submit the claim to Tufts Health Plan
Harvard Pilgrim Health Care member on the date of service	Submit the claim to Harvard Pilgrim Health Care
When the member is receiving services that span their plan transition date	Submit the claim to the plan in effect on the initial date of service (Example: Inpatient admission date)

Behavioral Health Insourcing

Insourced Behavioral Health Program - Effective November 1, 2023

- Behavioral health care is critical to the well-being and overall health of our members.
- Currently, Tufts Health Plan operates its own network of providers, while Harvard Pilgrim Health Care offers services through Optum/United Behavioral Health.

Insourced Behavioral Health Program Beginning November 1, 2023

- Behavioral health coverage and programs, including utilization and care management, will be delivered through Point32Health's internal functions and behavioral health team.
- The program emphases highly coordinated care management and outreach that connects behavioral and physical health.



Product Integration

- Behavioral Health Care

- For Tufts Health Plan Commercial members transitioning to Harvard Pilgrim Health Care, behavioral health care management services between now and November 1, 2023 will be managed by Optum/United Behavioral Health.
 - Optum/United Behavioral Health currently provides behavioral health services for Harvard Pilgrim Health Care.
 - When the insourcing of our behavioral health program occurs on November 1, 2023, Harvard Pilgrim Health Care will provide behavioral health care management services.



Harvard Pilgrim Health Care member with a date of service on or after the November 1, 2023 insourcing date	Submit the claim to Harvard Pilgrim Health Care

We want to provide you with an update on our plans to insource our behavioral health program for Harvard Pilgrim commercial members, which will now be taking place on Nov. 1, 2023.


Billing reminder for pelvic floor therapy

All products


As a reminder, Point32Health provides coverage for treatment of pelvic floor disorders. Members are eligible to receive clinical evaluation and physical therapy (PT) as outlined in their plan benefits, and providers should use diagnosis code 090.89 when billing for PT for pelvic floor disorders.




